SUBJECT: 2025-12R and 2026-01R to 2026-05R: NOTICE OF HEARING FOR CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATIONS 1, 5, 6, AND 7 REGARDING, WITHOUT LIMITATION, WAGERING ACCOUNTS (PERMISSIBLE DEPOSIT/WITHDRAWAL METHODS); SERVICE PROVIDERS AND CLOUD COMPUTING (INCLUDING REPEAL OF CLOUD COMPUTING SERVICE PROVIDER REGISTRATION PROVISIONS); DEFINITIONS OF "REGISTRANT" AND "REGISTRATION" AND CONFORMING ENFORCEMENT/APPLICABILITY UPDATES; ACCOUNTING/INTERNAL CONTROLS (INCLUDING LIVE ENTERTAINMENT TAX REFERENCES AND REPORTING/RETENTION REQUIREMENTS); FINDER'S FEES; OWNERSHIP RECORDS; AND DISCIPLINARY APPLICABILITY AND JURISDICTION.

Pursuant to *Nevada Revised Statutes* (NRS) [463.145\(1\)](#), [463.150\(1\)](#), and [463.156](#) to [463.1595](#), inclusive, and [Chapter 78](#), *Statutes of Nevada 2025* ([Senate Bill 46](#)), the Nevada Gaming Commission (NGC or Commission) will hold a public hearing to consider the adoption, amendment, or repeal of the regulation(s) identified below.

For Possible Adoption, Amendment, or Repeal

2025-12R: PROPOSED AMENDMENTS TO NGC REGULATIONS 5.225, 5.240, AND 5.242

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATIONS 5.225, 5.240, AND 5.242 REGARDING, WITHOUT LIMITATION, CLOUD COMPUTING ARRANGEMENTS AND SERVICE PROVIDER OVERSIGHT, INCLUDING REPEAL OF CLOUD COMPUTING SERVICE PROVIDER REGISTRATION REQUIREMENTS, UPDATES TO DEFINITIONS AND COMPLIANCE OBLIGATIONS, AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: In accordance with NRS 463.145, 463.150, to amend NGC Regulation 5.225 to provide additional permissible methods to deposit and withdraw funds from wagering accounts; to amend NGC Regulations 5.240 and 5.242 to repeal cloud computing service provider as a type of service provider that must be registered with the Board and repeal associated regulatory provisions, and to amend provisions related to who may act as a service provider without registering with the Board as a service provider, and to provide under what circumstances a licensee may utilize cloud computing services; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

REGULATION PROJECT 2025-12R HAS PROPOSED CONFORMING AMENDMENTS AS FOLLOWS:

PROPOSED CONFORMING AMENDMENTS TO NGC REGULATION 1.137

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 1.137 REGARDING, WITHOUT LIMITATION, UPDATING THE DEFINITION OF “HOSTING CENTER” TO CONFORM WITH PROPOSED AMENDMENTS TO NGC REGULATION 5.242; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: In accordance with NRS 463.145, 463.150, to amend the definition of “hosting center” in Regulation 1.137 to correspond with proposed changes to NGC Regulation 5.242 regarding cloud computing services; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

2026-01R: PROPOSED AMENDMENTS TO NGC REGULATIONS 1, 1.155, 5.030, 5.040, 5.060, AND 5.070

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATIONS 1, 1.155, 5.030, 5.040, 5.060, AND 5.070 REGARDING, WITHOUT LIMITATION, ADDING A DEFINITION OF “REGISTRANT,” CLARIFYING THE SCOPE OF “REGISTRATION,” AND CONFIRMING APPLICABILITY OF CERTAIN ENFORCEMENT AND DISCIPLINARY PROVISIONS TO LICENSEES, REGISTRANTS, PERSONS FOUND SUITABLE, AND THEIR AGENTS AND EMPLOYEES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: Pursuant to NRS 463.145 and 463.150, to amend NGC Regulations 1, 1.155, 5.030, 5.040, 5.060, and 5.070 to carry out the policies and provisions of Chapter 463 of NRS; to amend NGC Regulation 1 to add a definition of “registrant”; to amend NGC Regulation 1.155 to clarify the term “registration” applies to any registration of a person with the Board or Commission, other than a gaming employee registration, as required by the Nevada Gaming Control Act or the regulations adopted thereunder; to amend NGC Regulations 5.030, 5.040, 5.060, and 5.070 to specifically provide that the sections apply to any licensee, registrant, person found suitable by the Commission, and any agent or employee thereof; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

2026-02R: PROPOSED AMENDMENTS TO NGC REGULATIONS 6.090, 6.100, AND 6.115

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATIONS 6.090, 6.100, AND 6.115 REGARDING, WITHOUT LIMITATION, FINANCIAL PRACTICES AND ACCOUNTING REQUIREMENTS, INCLUDING INTERNAL CONTROL STANDARDS, REPORTING AND AUDIT/FINANCIAL STATEMENT OBLIGATIONS, AND NOTICE/APPROVAL REQUIREMENTS FOR CHANGES TO ACCOUNTING SYSTEMS OR PROCEDURES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: Pursuant to NRS 463.145, 463.150, and 463.157, to amend NGC Regulations 6.090, 6.100, and 6.115 to carry out the policies and provisions of Chapter 463 of NRS; To amend NGC Regulations 6.090(1) and 6.100(1) to add a reference to Chapter 368A of the NRS; to amend NGC Regulations 6.090(2), (7)-(8), and (10)-(13) to remove the requirement that a licensee must submit a copy of its written system of internal control to the Board, but instead provide it to the Board upon request; to amend NGC Regulation 6.090(9) to provide that the independent accountant engaged by the licensee need no longer perform any procedures or prepare reports required in the subsection in relation to the licensee's compliance with the minimum internal control standards regarding Nevada's Live Entertainment Tax ("LET") (NRS 368A); to amend NGC Regulation 6.090(15) to provide that the licensee's internal auditor need no longer perform the procedures or prepare the reports required under the subsection in regard to LET; to amend NGC Regulations 6.115(3) and (4) to adjust language to reflect the repeal of the requirement for licensees to submit copies of the written systems; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

2026-03R: PROPOSED AMENDMENTS TO VARIOUS SECTIONS OF NGC REGULATION 5.120

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 5.120 REGARDING, WITHOUT LIMITATION, FINDER'S FEES; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: Pursuant to NRS 463.145 and 463.150, to amend NGC Regulation 5.120 to increase the finder's fee from \$10,000 to \$30,000; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

2026-04R: PROPOSED AMENDMENTS TO NGC REGULATION 6.050

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 6.050 REGARDING, WITHOUT LIMITATION, CLARIFYING OWNERSHIP RECORDS REQUIREMENTS FOR AUDIT INSPECTIONS; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: Pursuant to NRS 463.145, 463.150, and 463.156 to 463.1595, inclusive, to amend NGC Regulation 6.050 to clarify that licensees are not required to have original ownership documents available in that copies are acceptable for audit inspections; to clarify that publicly traded companies are exempt; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

For Possible Adoption, Amendment, or Repeal

2026-05R: PROPOSED AMENDMENTS TO NGC REGULATIONS 7.010 AND 7.025

CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATIONS 7.010 AND 7.025 REGARDING, WITHOUT LIMITATION, DISCIPLINARY APPLICABILITY AND COMMISSION AND BOARD JURISDICTION, INCLUDING RETAINED JURISDICTION AND SURRENDER OF A LICENSE, REGISTRATION, OR FINDING OF SUITABILITY; AND OTHER MATTERS PROPERLY RELATED THERETO.

PURPOSE: In accordance with NRS 463.145, 463.150, and [Chapter 78, Statutes of Nevada 2025](#) (Senate Bill 46), to amend NGC Regulation 7.010 to correct and/or modify existing language; to adopt regulations clarifying that the jurisdiction of the Board and Commission in disciplinary matters is fully retained and is not divested in any circumstance, except as otherwise provided; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The Commission will consider the proposed regulation changes in accordance with the provisions of NRS [463.145](#), which provides that *on the date and at the time and place designated in the notice, the Commission shall afford any interested person or their authorized representative, or both, the opportunity to present statements, arguments or contentions in writing, with or without opportunity to present them orally*. These items will be heard by the Commission at its meeting on March 26, 2026, and may be continued and heard at subsequent meetings of the Commission as required to effectuate the above-stated purposes.
