SUBJECT: AMENDMENTS TO THE NEVADA GAMING CONTROL BOARD SURVEILLANCE STANDARDS FOR NONRESTRICTED AND RESTRICTED LICENSEES SECTIONS 1.010, 1.020, AND 2.010; STANDARDS 1-14

Pursuant to Nevada Gaming Commission (NGC or Commission) Regulation 5.160(3), this notice is to inform all licensees and interested parties that the Nevada Gaming Control Board (Board) Chair is proposing revisions to the Board's Surveillance Standards. **This notice supersedes Notice 2026-10 dated February 12, 2026.** This superseding notice and revised draft (dated February 26, 2026) reflect updates made after receiving industry feedback. The proposed revisions include, without limitation:

- Amendments to Surveillance Standards section 1.010 to revise, add, and remove definitions;
- Amendments to section 1.020 to update license categories from revenue-based to activity-based;
- Amendments to section 2.010 to update surveillance equipment and staffing/training requirements and to revise malfunction notification and remediation provisions;
- Amendments to Surveillance Standards 1-8 to update minimum surveillance coverage requirements for slot machines, table games, card games, keno, bingo, race books, sports pools, pari-mutuel books, casino cage and vault, count rooms, and security offices;
- Amendments to Surveillance Standard 9 to update minimum requirements for surveillance records and retention;
- Amendments to Surveillance Standards 10 and 11 to update surveillance requirements for gaming salons and club venues;
- Amendments to Surveillance Standard 12 to align digital recording standards with current technology;
- Amendments to Surveillance Standard 13 to update overall surveillance system requirements;
- The addition of Surveillance Standard 14 to address Restricted licensees; and
- Any other revisions that may be necessary and proper to effectuate these stated purposes.

These proposed changes will become effective on **April 3, 2026**. The updated Surveillance Standards will be posted on the Board's Gaming Statutes and Regulations webpage on that date.

Any licensee objecting to the proposed Surveillance Standards or revisions may file a written request for review of the Chair's administrative decision pursuant to NGC Regulation 5.160(4). If any licensee files a request for review, the effective date of the proposed standards or revisions will be stayed pending action by the Board and, if appealed, the Commission.
