At its meeting on January 29, 2026, the Nevada Gaming Commission (NGC) adopted amendments to certain provisions of the NGC Regulations, as identified below. These amendments took effect immediately upon adoption, except for the changes to NGC Regulation 22, which became effective on February 28, 2026.
