THE NEVADA GAMING CONTROL BOARD (NGCB) RELEASED FIGURES TODAY SHOWING THAT \$133.8 MILLION WAS WAGERED IN NEVADA'S 186 SPORTS BOOKS ON THIS YEAR'S SUPER BOWL.

NGCB CHAIRMAN MIKE DREITZER SAID, "UNAUDITED FIGURES SHOW A SPORTS BOOK WIN OF \$9,892,055 WAS RECORDED ON WAGERS TOTALING \$133,813,230. THIS RESULTED IN A HOLD PERCENTAGE OF 7.4%."
