



APPLICATION AND INVESTIGATIVE FEE SCHEDULE

A check or money order in the amount listed for each applicant or entity, to cover the application fee and if necessary, investigative fee must be submitted with the application. Checks are to be made payable to the Nevada Gaming Control Board and cannot be drawn on a foreign bank. Cash or credit cards are not accepted.

* Costs of investigation will be charged as provided by statute and regulation. The total cost of the investigation is to be borne by the applicant. This cost includes an hourly charge for the time expended by the agent or agents assigned to the application, all transportation, food, and lodging. Hourly expenses will be charged for travel time and time expended while agents are engaged in the investigation process. Before the investigation can begin the applicant must provide a deposit in an amount equal to the total estimated expenses, including the hourly charges.

In accordance with NRS 353.1467, all payments of money owed to a state agency for taxes, interest, penalties, or any other obligations that, in the aggregate, amount to **\$10,000 or more**, must be made by electronic transfer in a method allowed by the state agency.
