- ☐ Dispute resolution document (*if applicable*) – This is documentation that provided detail explanation/evidence of the dispute resolution process in the jurisdiction (other than Nevada) in which this link will be used. If any dispute arises with the link, the other jurisdiction's dispute resolution process must be comparable to that of NGCB's.
- ☐ Copy of the Internal Controls that have been submitted to Audit Division (*if not adding a jurisdiction to the link*).
