

PROPOSED AMENDMENTS TO REGULATION 28

PURPOSE: In accordance with NRS 463.145, 463.150, and 463.151, to amend NGC Regulation 28.040 to repeal distribution requirements and instead require publication of the list on the Board's website; to amend NGC Regulation 28.090 to repeal the requirements that a licensee, its agents, or employees request an excluded person to not enter or, if on the premises, to immediately leave, and to notify the appropriate local law enforcement agency if the excluded person fails to comply, while retaining the Board notification requirement and to amend related provisions; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

28.040. Distribution and contents of the list.

1. The list shall be open to public inspection and ~~{shall be distributed to:~~

~~—(a) Every licensed gaming establishment within the state that conducts pari-mutuel wagering or operates any race book, sports pool or any game, other than slot machines only;~~

~~—(b) Law enforcement agencies situated in the State of Nevada}~~
published on the Board's website.

2. The following information and data shall be provided on the list for each excluded person:

(a) The full name and all aliases the person is believed to have used;

(b) Description of the person's physical appearance, including height, weight, type of build, color of hair and eyes, and any other physical characteristics which may assist in the identification of the person;

(c) Date of birth;

(d) The effective date the person's name was placed on the list;

(e) A photograph and the date thereof.

28.090 ~~[Duty]~~ Duties of Licensee ~~[to Exclude]~~.

1. No Change.

2. Whenever an excluded person enters ~~[or attempts to enter]~~ or is upon the premises of a licensed gaming establishment that conducts pari-mutuel wagering or operates any race book, sports pool or games, other than slot machines only, and is recognized by the licensee, its agents or employees, then the licensee and its agents or employees must ~~[do the following:~~

~~—(a) If~~ immediately notify the Board of the presence of the excluded person in any area of the gaming establishment~~;~~

~~—(b) Request the excluded person to not enter or if on the premises to immediately leave;~~

~~—(c) Notify the appropriate local law enforcement agency and the Board if the excluded person fails to comply with the request of the licensee, its agents or employees].~~

3. Failure to ~~[request the excluded person to leave or to prohibit entry of the person upon its premises in a timely fashion or failure to]~~ properly notify the Board of the presence of the excluded person is an unsuitable method of operation.
