PURPOSE: To require specific language be incorporated at the front of book house rules; to remove the requirement that the Chair approve house rules and parlay card rules or amendments thereto; to require maintenance of prior versions of house rules and parlay card rules; to authorize the Chair to direct a book to amend its house rules or parlay card rules; to update the acceptable sources of outcome reporting; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

REGULATION 22 RACE BOOKS AND SPORTS POOLS

22.060 Acceptance of wagers.

Licensed sports pools may accept wagers, including parlay card wagers, as to which of the participating contestants will win specified sports events and as to whether the total points scored in a specified game, match, or similar sports event will be higher or lower than a number specified for that event. Licensed sports pools shall not accept wagers, including parlay card wagers, on other contingencies unless their outcomes are reported [in newspapers of general circulation]:
 - (a) Through reputable national or international media organizations or
- (b) [i] In official, public records maintained by the appropriate league or other governing body or by the appropriate league or other governing body designated statistics provider. [or]
- <u>→</u>*U*nless the pertinent sports events are televised live at the book and a book employee other than a betting ticket writer monitors the telecast, records the occurrence of the pertinent events and contingencies simultaneously with their occurrence, and records the time of their occurrence.

22.090 Parlay card wagers.

Prior to adopting or amending parlay card rules, a book shall submit such rules to the <u>Board</u> [Chair for approval]. <u>The Chair may direct a book to amend its parlay card rules at any time.</u> A book shall maintain a copy of prior versions of its parlay card rules for at least 5 years.

22.150 House rules.

1. Each book shall adopt, conspicuously display at its licensed premises, and adhere to written, comprehensive house rules governing wagering transactions with patrons. Without limiting the generality of the foregoing, the rules must specify the amounts to be paid on winning wagers,

the effect of schedule changes, the redemption period for winning tickets, and the method of noticing odds or line changes to patrons. House rules must state that wagers may be accepted at other than the currently posted terms, if applicable. Prior to adopting or amending such house rules, a book shall submit such rules to the <u>Board</u> [Chair for approvat]. <u>The Chair may direct a book to amend its house rules at any time</u>. <u>A book shall maintain a copy of prior versions of its house rules for at least 5 years</u>.

2. Each book shall incorporate the following language at the front of its house rules:
(a) These house rules ("House Rules") are subject to all applicable Statutes, Rules, and Regulations ("Applicable Laws") as enforced and interpreted by the Nevada Gaming Control Board (NGCB). In the event of any conflict between the House Rules and the Applicable Laws, it is expressly understood that all Applicable Laws will prevail. Moreover, the interpretation of the Applicable Laws by the NGCB shall prevail at all times.

(b) Rescission of wagers is subject to approval by the NGCB pursuant to Nevada Gaming Commission Regulation 22.115. Other disputes which cannot be resolved to the satisfaction of the patron may be subject to resolution by the NGCB pursuant to the patron dispute process set out in NRS 463.362 et seq. and Nevada Gaming Commission Regulation 7A.
