Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2014

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$906,904,294 for the month of June 2014. This amounts to a 14.36% increase compared to June 2013, when licensees reported a gaming win of \$793,058,748. For the fiscal year (July 1, 2013 through June 30, 2014), gaming win has increased 2.94%.

Percentage Fee Collections for the Month of July 2014

The State collected \$43,567,260 in percentage fees during the month of July 2014*, based upon the taxable revenues generated in June 2014. This represents a 0.51% (or \$222,766) increase compared to the prior year's July, when percentage fee collections were \$43,344,494.
