Win Revenue Summary – May 2000

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$799,093,606 for the month of May 2000. This amounts to a 5.34% increase compared to May 1999, when licensees reported a gaming win of \$758,590,869.

Percentage Fee Tax Collections for the Month of June 2000

The State collected \$52,031,406 in percentage fee taxes during the month of June 2000, based upon the taxable revenues generated in May 2000. This represents a 7.49% (or \$3,627,017) increase compared to the prior year's June (1999), when percentage fee collections were \$48,404,389.

On a fiscal year (July 1, 1999 through June 30, 2000), the State of Nevada collected \$560,145,492 in percentage fee taxes. This represents a 12.82% increase from the prior fiscal year period when collections totaled \$496,479,878.
