May 2004 Nevada Gaming Revenues and Collections

Win Revenue Summary – May 2004

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$908,241,538 for the month of May 2004. This amounts to a 12.72% <u>increase</u> compared to May 2003, when licensees reported a gaming win of \$805,765,773. For the fiscal year (July 1, 2003 through May 31, 2004), gaming win has increased 5.71%.

Percentage Fee Collections for the Month of June 2004

The State collected \$55,229,640 in percentage fees during the month of June 2004, based upon the taxable revenues generated in May 2004. This represents an 11.29% (or \$5,603,393) increase compared to the prior year's June (2003), when percentage fee collections were \$49,626,247. During the 20th Special Legislative Session percentage fee rates were increased by 8.6%, which should be taken into consideration when making comparisons with the prior fiscal year. The new percentage fee rates became effective in September.

Governor Kenny Guinn's Comments`

'I am pleased with the resurgence and strength of our state's largest industry considering the proliferation of gaming nationwide, especially next door in California. Collections from gaming are now \$38 million ahead of what the economic forum projected that puts the state's general fund \$100 million ahead of projections. Conversely, I would be faced with making painful cuts of \$270 million in the first year of the biennium in education, public safety and welfare had the legislature not passed the current budget in the 2003 legislature."
