Nevada Gaming Revenues and Collections

Win Revenue Summary – September 2013

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$958,805,870 for the month of September 2013. This amounts to a 7.41% increase compared to September 2012, when licensees reported a gaming win of \$892,698,404. For the fiscal year (July 1, 2013 through September 30, 2013), gaming win has increased 2.97%.

The State collected \$62,919,706 in percentage fees during the month of October 2013*, based upon the taxable revenues generated in September 2013. This represents an 11.48% (or \$8,158,456) decrease compared to the prior year's September, when percentage fee collections were \$71,078,162.
