2024-05R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NGC REGULATION 5.102 REGARDING, WITHOUT LIMITATION, AMENDING TEMPORARY ARMED SECURITY PERSONNEL REGISTRATION REQUIREMENTS.

<u>PURPOSE</u>: To amend NGC Regulation 5 to align the process for applying for registration as a gaming employee for armed security personnel with the amended procedures of the Department of Public Safety; to clarify the acceptable documents for temporary registration of armed security personnel; to clarify qualifying records and their submission and maintenance; to clarify the time period for completion of registration of armed security personnel; and to take such additional actions as may be necessary and proper to effectuate this stated purpose.

2. FOR FINAL ADOPTION

2024-05R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO SECTIONS 16.010 AND 16.405 OF NGC REGULATION 16 REGARDING, WITHOUT LIMITATION, AMENDING THE DEFINITION OF PROSCRIBED ACTIVITY TO MATCH STATUTORY LANGUAGE AND AMENDMENTS REGARDING REQUIREMENTS FOR BENEFICIAL OWNERS OF VOTING SECURITIES OF PUBLICLY TRADED COMPANIES.

<u>PURPOSE:</u> In accordance with NRS 463.145, NRS 463.150, and NRS 463.643, to amend the definition of "proscribed activity" to match the explicit statutory language; for any person who becomes subject to NRS 463.643(3), to establish the date by which such person must notify the NGC that a report has been filed with the Securities and Exchange Commission; for any person who becomes subject to NRS 463.643(4), to establish the date by which such person must apply to the NGC for a finding of suitability; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

3. FOR FINAL ADOPTION

2024-05R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO SECTIONS 22.060 AND 22.115 OF NGC REGULATION 22 REGARDING, WITHOUT LIMITATION, REQUIRING REPORTING OF WAGERS ON OUTCOMES WHICH HAVE ALREADY BEEN DETERMINED AND CLARIFYING WHEN BOARD CHAIR APPROVAL FOR RESCISSION IS NECESSARY.
