SUBJECT: ADOPTION OF REGULATION 22.121 AND RELEASE OF SUSPICIOUS WAGERING REPORT (SWR)

On January 25, 2001 the Nevada Gaming Commission adopted Regulation 22.121, which requires a licensee to report to the Gaming Control Board any suspicious wagering taking place in its sports pool. Included in the category of suspicious wagering activity would be any activity that would indicate line or point spread manipulation, unusual betting patterns or any other activity thought to be suspicious. This regulation was adopted as part of Nevada's comprehensive regulatory structure, which is designed to protect the integrity of sports wagering and to provide protection against potential manipulations of sports wagering or other irregularities.

Regulation 22.121(2) requires that suspicious wagering be reported on a form developed by the Board. Attached is the form to be used ("SWR"). This form is available on the Gaming Control Board's website at <a href="http://gaming.state.nv.us/">http://gaming.state.nv.us/</a>. Those not able to access the form on our website may contact the Board's Enforcement Division at (702) 486-2020 for additional copies.

As specified in the regulation, these reports should be filed within seven calendar days after the initial detection of the incident, or if additional time is needed to identify the suspect, no later than 14 days after the incident. Instructions for completing the form are included on the back of the form.

The regulation also requires the licensee to immediately notify the Gaming Control Board by telephone of any activity requiring immediate attention. Such calls should be made to the Enforcement Division at (702) 486-2020.

Suspicious wagering reporting does not take the place of suspicious activity reporting pursuant Regulation 6A.100. Suspicious wagering activity may involve reporting under both regulations.

Any questions involving reports of suspicious sports wagers should be directed to the Enforcement Division.
