RE: NOTICE OF TRAINING SCHEDULE FOR THE NEW GAMING EMPLOYEE REGISTRATION PROGRAM

In July 2003, the State Legislature enacted new legislation which radically changed the "work permit" program as it applies to gaming employees throughout the state of Nevada. These changes to NRS 463.335 (the Gaming Control Act) essentially eliminated the work permit program which has been administered by local law enforcement agencies. This program has been replaced with the new gaming employee registration program which will be administered statewide by the Gaming Control Board. The effective date of the new program is January 1, 2004.

As noted, changes to the Gaming Control Act have been enacted by the Legislature; the corresponding regulations are in the final approval process. When adopted by the Nevada Gaming Commission, they will be posted on the Board's website (http://www.gaming.state.nv.us/). Additionally, all forms necessary to complete the "Application for Registration" will be available on the website.

As these changes are far-reaching and place additional responsibilities on both nonrestricted gaming licensees and the Gaming Control Board, it is appropriate to conduct training to ensure that all affected licensees are aware of the new statutes and regulations, and are prepared to implement the new registration program. To that end, in November and December, representatives of the Enforcement Division of the Gaming Control Board will conduct numerous training sessions, statewide, relative to the implementation of the new Gaming Employee Registration Program. Representatives of the Board's Information Services Office will also be available to respond to questions and concerns during sessions. If you have specific questions you would like to have addressed, you may include those with your registration e-mail.

Due to anticipated attendance at these training sessions, it is necessary for attendees to pre-register with the Board. Therefore, please respond by e-mail indicating the training session you plan to attend. Each property should send a single e-mail reflecting
