The Nevada Gaming Commission (NGC) will hold a public hearing for the purpose of considering adoption, amendment or repeal of the regulation(s) stated below.

IN COMPLIANCE WITH THE GOVERNOR'S EMERGENCY DIRECTIVE #006, DATED MARCH 22, 2020, THE CONSIDERATION OF THE ADOPTION, AMENDMENT, OR REPEAL OF THE REGULATIONS STATED BELOW DURING THE MEETING OF THE NEVADA GAMING COMMISSION COULD BE CONDUCTED BY MEANS OF ELECTRONIC COMMUNICATION. 2021-01R: CONSIDERATION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 7A REGARDING, WITHOUT LIMITATION, REVIEWING AND UPDATING REGULATION 7A.

PURPOSE: To review and update Regulation 7A in its entirety; to create a definition of patron; to instate a limitations period; to revise requirements regarding service and notices; to modify requirements regarding the initiation of a hearing and notice thereof; to specify the effect of failure to serve a respondent within a certain time period; to expand the mediums of communication through which a hearing may be conducted; to modify subpoena requirements including witness fees and when such fees must be paid; to modify continuance approvals; to modify the impact of a default or failure to appear by a party; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. IF THE JANUARY NGC MEETING IS HELD BY MEANS OF ELECTRONIC COMMUNICATION, ANY PERSON DESIRING TO PRESENT STATEMENTS, ARGUMENTS OR CONTENTIONS CONCERNING THE PROPOSED REGULATION CHANGES MUST PROVIDE SUCH IN WRITING TO THE EXECUTIVE SECRETARY AT regcomments@gcb.nv.gov.

These items will be heard by the NGC at the January 21, 2021 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
