The Nevada Gaming Commission (NGC) will hold a public hearing for the purpose of considering adoption, amendment or repeal of the regulation(s) stated below.

IN COMPLIANCE WITH THE GOVERNOR'S EMERGENCY DIRECTIVE #006, DATED MARCH 22, 2020, THE CONSIDERATION OF THE ADOPTION, AMENDMENT, OR REPEAL OF THE REGULATIONS STATED BELOW DURING THE MEETING OF THE NEVADA GAMING COMMISSION COULD BE CONDUCTED BY MEANS OF ELECTRONIC COMMUNICATION. 2020-04R: CONSIDERATION OF ADOPTION OF PROPOSED AMENDMENTS TO NEVADA GAMING COMMISSION REGULATION 26C REGARDING, WITHOUT LIMITATION, PARI-MUTUEL HORSE WAGERING ACCOUNTS.

PURPOSE: To update account wagering system requirements so they are in-line with the account wagering requirements found in Regulation 22.145, including removing the requirement of separate wagering accounts for pari-mutuel horse race wagering, acceptance of out-of-state nonpari-mutuel wagers if they become legal, and references to other events; and to take such additional action as may be necessary and proper to effectuate these stated purposes.

The proposed regulation changes will be considered by the NGC in accordance with the provisions of NRS 463.145, which provides that on the date and at the time and place designated, any interested person, or their duly authorized representative, or both, shall be afforded the opportunity to present statements, arguments or contentions in writing, with or without the opportunity to present the same orally. IF THE SEPTEMBER NGC MEETING IS HELD BY MEANS OF ELECTRONIC COMMUNICATION, ANY PERSON DESIRING TO PRESENT STATEMENTS, ARGUMENTS OR CONTENTIONS CONCERNING THE PROPOSED REGULATION CHANGES MUST PROVIDE SUCH IN WRITING TO THE EXECUTIVE SECRETARY AT regcomments@gcb.nv.gov.

These items will be heard by the NGC at the September 24, 2020 meeting, and may be continued and heard at subsequent meetings of the NGC as required to effectuate the above-stated purposes.
