- 4. THAT the Trust Agreement between IRVING KAYE and AMERICAN NATIONAL BANK AND TRUST COMPANY, Chicago, Illinois, filed with the 10 State Gaming Control Board on March 12, 1975, shall be performed 11 and observed strictly in accordance with its terms.
