- b. The application of United Gaming, Inc. for an amendment to its Order of Registration.

- 2. THAT paragraph 5 of the Third Revised Order of Registration of United Gaming, Inc. entered on July 25, 1991, is hereby rescinded and superseded in its entirety, and the following language is substituted in lieu thereof:
- "5. THAT United Coin Machine Co. is licensed as a manufacturer, distributor, an operator of a slot machine route, and to conduct nonrestricted gaming operations (slot machines only) at Hughes Aviation Services, 6005 South Las Vegas Boulevard, Las Vegas, Albertson's #148, 195 West Plumb Lane, Reno, Albertson's #637, 1570 North Eastern Avenue, Las Vegas, Albertson's #1616, 3160 North Rainbow Boulevard, Las Vegas, and Albertson's #1621, 9200 West Sahara Avenue, Las Vegas."
- 3. THAT except as expressly modified by this Amendment No. 4 to Third Revised Order of Registration, or other Commission action, all other terms and conditions of the Third Revised Order of Registration of United Gaming, Inc. entered on July 25, 1991, and of the Amendments Nos. 1, 2, and 3 thereto entered
