AMENDMENT NO. 6 TO ORDER OF REGISTRATION

THIS MATTER came on regularly for hearing before the State Gaming Control Board and the Nevada Gaming Commission at Carson City, Nevada, on August 17, 1978.

THE APPLICANT having presented evidence in support of its application, and the Board having investigated the application and having made its recommendation to the Commission, and

NO PERSON have appeared in opposition to the application;

IT IS HEREBY ORDERED BY THE NEVADA GAMING COMMISSION UPON THE RECOMMENDATION OF THE STATE GAMING CONTROL BOARD:

- 1. That the application of Meyer Goldman to amend the order of registration of Hyatt Corporation by permitting Meyer Goldman as Trustee of the P. G. Trusts to modify the Agreement and Undertaking made and entered with this Commission on January 15, 1973, be, and hereby is, accepted as filed.
- 2. That paragraph 4(e) of the order of registration of Hyatt Corporation dated January 18, 1973, be, and the same hereby is, amended to permit the Agreement and Undertaking dated January 15, 1973, of Meyer Goldman, Trustee

- of the P. G. Trusts, to be rescinded in its entirety, subject to the conditions imposed herein upon the order of registration of Hyatt Corporation.
- 3. That neither Hyatt Corporation nor any other person controlling, controlled by, or under common control with Hyatt Corporation shall have any involvement in gaming or parimutuel wagering outside the State of Nevada without first obtaining the approval of the Nevada Gaming Commission except (a) as provided by NRS 463.690(2), and (b) as permitted by the Commission's action on January 18, 1973, but limited to the extent described on pages 3 and 4 of the application of Meyer Goldman filed with the Gaming Control Board on July 27, 1978.
- 4. That paragraph 3 of the Commission's amended order of registration for Hyatt Corporation dated August 23, 1973, be, and hereby is, rescinded, and further, that pursuant to NRS 463.625(2), Hyatt Corporation be, and hereby is, exempted from compliance with NRS 463.585(1), (2), (5), (6), and (7), and NRS 463.595 through NRS 463.615, inclusive, and shall instead comply with NRS 463.635 through NRS 463.645, inclusive.
- 5. That Hyatt Corporation be, and it hereby is, exempted from Reg. 15, except for the provisions of Reg. 15.585.4-1, and shall instead comply with Reg. 16.
- 6. That the Commission hereby expressly finds that the exemptions hereinabove granted are consistent with the state policy set forth in NRS 463.130 and NRS 463.489(2).
