**SUBJECT:** **Casino Closure (Temporary and Permanent) Guidelines for Restricted Gaming Establishments**

---

This Notice to Licensees constitutes a policy statement of the Nevada Gaming Control Board ("Board") concerning casino closure requirements for restricted gaming establishments.

### Permanent Closure

Pursuant to Nevada Gaming Commission ("NGC") Regulation 9.010 (2)(a), a licensee who surrenders, abandons, or quits their licensed gaming establishment shall notify the Board immediately of such action and surrender the gaming license to the Board within 10 days from the time of permanent closure. Failure to notify the Board in a timely manner may result in disciplinary action, including but not limited to penalties.

### Temporary Closure

Pursuant to NGC Regulation 9.010 (2)(b), a licensee who plans to close all gambling games for a period exceeding 30 days shall submit a written request to the Board for an approval to close all gambling games for a longer period. The normal bankroll requirements will be temporarily waived during the period of temporary closure.

The Board's Tax and License Division should be notified of such closure or a temporary closure request be submitted via email at [taxandlicense@gcb.nv.gov](mailto:taxandlicense@gcb.nv.gov).

Furthermore, if your licensed gaming establishment offers a progressive slot machine, you shall not reduce the amount of a progressive payoff or otherwise eliminate a progressive payoff schedule without an administrative approval from the Board Chair pursuant to NGC Regulation 5.110. A request to remove or eliminate the progressive amount should be submitted to the Board's Audit Division via email at [progressiverequest@gcb.nv.gov](mailto:progressiverequest@gcb.nv.gov).
