**ORDER OF DENIAL**

THIS MATTER having come on for hearing before the NEVADA GAMING CONTROL BOARD ("BOARD") on April 9, 2025, in Las Vegas, Nevada, on the above-captioned Application and Request, with MATTHEW ROY GALANTI ("GALANTI") having appeared at the hearing without counsel, and the BOARD having received and reviewed all information relative thereto;

WHEREAS the BOARD having denied the Request to Withdraw Application in accordance with Nevada Gaming Commission ("NGC" or "Commission") Regulation 4.140;

AND WHEREAS the BOARD having determined that GALANTI failed to satisfy the burden of proving his qualifications to be licensed as a key employee of NEVADA RESTAURANT SERVICES, INC. ("NRSI"), pursuant to Nevada Revised Statute ("NRS") 463.5735(1) as required by NRS 463.170(1), (2), and (3)(a), NRS 463.339, and by NGC Regulations 3.090(1) and 4.040(1) and (2); and having specifically found:

1           1.     During the BOARD's investigation relating to his application, GALANTI was  
2 not forthcoming and truthful with BOARD agents about previous infractions committed at  
3 prior places of employment in violation of NRS 463.339 and NGC Regulation 4.040(2);

4           2.     During interviews conducted by BOARD agents between May 28, 2024 and  
5 April 9, 2024, GALANTI provided conflicting or false information in violation of NRS  
6 463.339 and NGC Regulation 4.040(2).

7           3.     During the April 9, 2025 hearing on his application, GALANTI provided false,  
8 misleading, and incomplete testimony to the BOARD in response to questions regarding  
9 his employment history in violation of NRS 463.339 and NGC Regulation 4.040(2).

10          4.     Through the investigation and the hearing on his application, GALANTI has  
11 failed to establish that he is a person of good character, honesty, and integrity as required  
12 by NRS 463.170(1)(a);

13          5.     Through his interactions with the BOARD, GALANTI has failed to provide  
14 the BOARD with full and accurate information relating to his application as required by  
15 NRS 463.339; and

16          6.     GALANTI has violated NGC Regulation 4.040(2) by having made untrue  
17 statements of material fact in his application and during the hearing on his application  
18 before the BOARD; by having willfully omitted required material facts from his application  
19 and his testimony during the hearing on his application held before the BOARD; and by  
20 having failed to clarify answers provided to the BOARD during the BOARD's investigation  
21 of his application and during the hearing on his application before the BOARD so as to  
22 render them misleading.

23           AND WHEREAS the BOARD makes the findings and conclusions set forth herein  
24 based upon the information and materials provided and obtained during its investigation  
25 of GALANTI's application and the testimony provided during the hearing on his application  
26 held on April 9, 2025;

27           IT IS HEREBY ORDERED, upon majority vote, that a recommendation of denial of  
28 GALANTI's application be, and hereby issued, to the Commission pursuant to NRS

1 463.1405(3) and NRS 463.210(3), said recommendation being based upon NRS 463.0129  
2 and NRS 463.170.
