AND WHEREAS the Board having granted with prejudice the request for withdraw of the Application of ATOM GERALD MILLER for licensure as a Member and Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN in accordance with NGC Regulation 4.140;

AND WHEREAS the Board having denied the request for withdraw of the Application of KEVIN MARTIN SCHANDA for licensure as a Member and Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN in accordance with NGC Regulation 4.140;

AND WHEREAS the Board determined that the applicant KEVIN MARTIN SCHANDA failed to satisfy the burden of proving his qualifications to be licensed as a Member and Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN pursuant to Nevada Revised Statute (NRS) 463.5735(1) as required by NRS 463.170(1), (2)(a), and (3), and by NGC Regulation 3.090(1)(c); and having specifically found that the applicant KEVIN MARTIN SCHANDA failed to prove himself to be a person of good character, honesty and integrity in his business practices as a Member and Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN, particularly those practices related to his dealings with vendors, employees and fellow investors thereof; and having further specifically found that the applicant KEVIN MARTIN SCHANDA failed to prove that he has adequate business probity, competence, and experience to own and operate a licensed gaming establishment within the State of Nevada. Consequently, good cause appearing:

IT IS HEREBY ORDERED, upon unanimous vote, that a recommendation of denial of the Application of KEVIN MARTIN SCHANDA for Licensure as a Member and Manager of MIDTOWN LOUNGE LLC, dba MIDTOWN, be and hereby is issued to the NGC pursuant to
